

WHEREAS the three Trusts are desirous of

(a) establishing and maintaining a hospital and a school to be constructed in the property known as "Rama Vilas", situated in Luz Church Road, Mylapore, Madras, which has recently been purchased by the Thirupani Trust for this purpose and (b) repairing, renovating, re-constructing and/or expanding Sir M.Ct. Muthiah Chettiar High School, Lady Muthiah Chettiar Girls High School and M.Ct.M. Chidambaram Chettyar Memorial Boys Hostel, all situated in Madras and M.Ct.M. Chidambaram Chettyar Memorial Higher Elementary School, Kanadukathan.

WHEREAS in view of the magnitude of the scheme and especially in order to expeditiously construct the hospital and school, it is considered expedient that a separate Trust should be created for the aforesaid pruposes, appointing a competent and independent body of persons as the Board of Trustees;

WHEREAS accordingly the Trustees named above were appointed as Trustees and they have consented to act in such capacity;

AND WHEREAS it is considered expedient that an Indenture of Trust should be executed by the parties hereto:

NOW THIS INDENTURE OF TRUST WITNESSETH as follows:

- The Trust hereby constituted shall be called "M.Ct. M. Chidambaram Chettyar Foundation".
- 2) Sri F.B. Pithavadian, Sri C. Ramakrishna and Sri T.M. Srinivasan shall constitute the Board of Trustees.
- 3) The Settlors hereby transfer a sum of Rs.15,000/- (Rupees fifteen thousand) to the Board of Trustees made up of a sum of Rs.5,000/- contributed out of each of the three Trusts. The Board of Trustees shall hold the said funds and any other funds or assets that may hereafter be transferred by the Settlors or any other persons and all income from such funds or assets and all accumulations thereof for the objects and purposes hereinafter mentioned, namely,
- (a) to construct a hospital in the premises belonging to the Thirupani Trust and known as "Rama Vilas", situated in Luz Church Road, Mylapore, Madras, and maintaining and managing the said hospital, and for such purpose to prepare a scheme and carry it out as expeditiously as possible;
- (b) to repair, renovate, re-construct and/or expand Sir M.Ct. Muthiah Chettiar High School, Lady Muthiah Chettiar Girls High School and M.Ct.M. Chidambaram Chettyar Memorial Boys Hostel, all situated in

- (c) to meet all expenses necessary and incidental for carrying out the aforesaid purposes and for management of the Trust hereby constituted:
- (d) subject to availability of funds after providing for the aforesaid objects, to construct a school for education in "Rama Vilas" property and maintain and manage the school;
- 4) The Rama Vilas property will continue to be the property of the Thirupani Trust. The Board of Trustmas are, however, authorised to enter the premises, construct the hospital and school as aforesaid and manage the hospital and the school. The property tax and other outgoints in respect of the Rama Vilas property shall be paid by the Board of Trustees out of the funds available with them.
- 5) The Board of Trustees hereby undertake to act diligently, promptly and expeditiously in carrying out the aforesaid objects and utilise the said funds only for the said objects and not utilise them for any other purposes whatsoever.
- 6) Every Member of the Board of Trustees shall be entitled to a sitting fee of Rs. 25/- for every meeting

- 7) The Board of Trustees shall give the Settlors monthly reports of the progress of the works and see that all the works are completed as quickly as possible and, in any case before the end of 1974. On completion of the construction of the hospital, the Board of Trustees shall manage and run the hospital.
- 8) The Board of Trustees shall meet from time to time and take decisions on all important matters. In case of difference of opinion among the members of the Board of Trustees, the opinion of the majority shall prevail.
- 9) The Board of Trustees may make regulations for the convening and holding of its meetings and they may also make regulations in regard to the execution of the works and management of the hospital entrusted to the Board under these presents:
- 10) The Trustees for the time being of Thirupani Trust, the Family Trust and M.Ct. Trust may appoint additional members of the Board of Trustees.
- 11) Any member of the Board of Trustees may, by notice in writing to the Trustees of the Thirupani Trust, the Family Trust and M.Ct. Trust retire from the Board. Any vacancy arising in the Board of

Trustees may be filled by the Trustees for the time being of Thirupani Trust, the Family Trust and M.Ct. Trust.

- 12) The Board of Trustees shall keep a Minutes Book and record the minutes of the proceedings of their meetings.
- 13) The Board of Trustees shall exercise all powers necessary for or incidental to the carrying out of the works and management of the hospital. In particular, the Board of Trustees may appoint a Secretary to attend to the affairs of this Trust, Engineers and other staff and workers for carrying out the construction works, and Superintendent, Doctors and other staff for managing and running the hospital, to fix the terms of appointment or terminate the appointment in such manner as they may deem fit. The Superintendent of the hospital may be appointed as a Joint Secretary. The Board may engage Architects and Engineers for construction of the hospital and school and other works mentioned in clause 3 hereof. The Board may, if it deems fit to do so, engage the firm of Architects "Prynee, Abbott & Davis" of which Mr. Pithavadian is a partner, and, in such case the Board may pay a reasonable remuneration to the said firm for whatever services that are rendered by them or by Mr. Pithavadian as their partner. - 15) The Board of Trustees may, by their unanimous decision, borrow any amounts required for the purpose of this Trust and for such purpose may give security of all or any of the assets of the Trust.
- 16) Any amount not immediately required for construction of the hospital or the other works and objects mentioned in clause 3 hereof, shall be invested in such investments as the Board of Trustees may decide or be deposited in any account with a banking company to which the Banking Regulation Act, 1949, applies, including any bank or banking institutions referred to in Section 51 of that Act.
